Overall Inspection Comment:

A routine food inspection was conducted on February 10th, 2025. The following observations were made:

All hand wash sinks were stocked with soap. Water dispensed from all hand wash sinks reached 100F. All hand wash sinks were free of debris in their basins and were able to be accessed by staff easily.

3-compartment sink was set up correctly. Water dispensed from sink was temperatures at 120F. Facility uses quaternary ammonia.

All refrigeration units were temperatures below 41F. Food inspection units were stored according to the California Retail Food Code.

All freezer units were temperatured below 10F. All food was stored 6 inches off of the ground.

Cold holding units were temperatures below 41F. All units contained food that was labeled and covered.

Soda nozzles were clean and free of debris.

Bar area was clean and free of debris. No pest were observed in bottles. Tap nozzles were clean and free of debris.

Food handlers certificates were valid.

Please obtain quaternary ammonia test strips.

Please provide paper towels nexts to all hand sinks

Please secure compressed gas cylinders to wall.
