




Staff turnover and new and ongoing barriers to implementation in FY 2022-2023 resulted in discontinuities and gaps in early childhood service environments.

- First 5 reached 800 children or 6% of the 0 to 5 population in Kings County.
- Partners reached 1,418 parents and caregivers across funded initiatives.
- Workforce development strategies reached 285 ECE providers to enhance early care and education quality.






Child Characteristics | 2022-2023

- Seventy-five percent of children were Hispanic, 12% were Multi-Racial, 6% were White, and 7% were Other Races.
- Nearly half (46%) of children were from Spanish speaking households.
- Sixteen percent of children (16%) were identified with special educational needs.
- Twenty-one percent of children were infants and toddlers and 71% were preschool age.
- Among children served through FRCs, 60% were insured under Medi-Cal, 26% had private insurance, 3% were uninsured, and 6% had unknown coverage.

UCP Parent & Me and Special Needs | 2022-2023

- Commission allocated \$417,810 for United Cerebral Palsy of Central California (UCP) to promote equitable access to quality early learning for children at-risk for developmental delays. This fills a gap in systems of care for children ineligible for special developmental services.
- The Special Needs Project (SNP) reached 64 children—100% of whom were 0-3 years of age. UCP staff assessed 49 children with IDEA special needs, provided coaching to 113 ECE providers, and supported 19 special needs children in Parent & Me settings as part of its Early Start inclusion program. This creates opportunities for interaction with typically developing children.
- Parent & Me programs delivered 1,174 interactive sessions, reaching 167 children and 145 parents or caregivers. Another 142 children receiving developmental screenings. Services were impacted by program downsizing with the transition to a 10-month operating year. This resulted in a 20% decrease in number of children served.



New Projects



Unite Us Referral Exchange | 2022-2023

- Commission invested \$38,000 to support ongoing development of the Kings County Referral Exchange (RE) on the Unite Us platform.
- The RE grew to support 36 active user organizations from healthcare, education, and social services, including 17 providers who serve children 0-5 and their families.
- Kings United Way (KUW) provided capacity building support to 15 community organizations to facilitate their participation on the platform and continued to prioritize onboarding of new providers.
- KUW encountered early barriers that limited widescale adoption. KUW was later informed that Unite Us was restricting KUW's access to demo the platform and would not release county stakeholder data.
- KUW remains committed to the concept of a shared, electronic referral system but is no longer pursuing development of the Unite Us platform.





Family Resource Centers



Family Resource Centers | 2022-2023

- FRCs operated across four Kings County communities in FY 2022-23 and reached 565 children and 550 parents and caregivers.
- Four centers continued to offer an array of school readiness and family support services to underserved children and families.
- Early childhood programming featured classes for infants and caregivers, toddlers, and preschool-age children. Topics included, but were not limited to art, music, cooking and nutrition, movement, storytelling, and sensory exploration. FRCs also sponsored family literacy activities and socialization events.
- Onsite resources available to families included translation assistance, book giveaways, incentive closets, and access to office facilities (e.g. fax, phone, copier, computer).
- Families were also referred to community-based services including preschool and childcare spaces, employment assistance, utilities assistance, legal services, medical services, WIC, and special education. FRCs also made 357 referrals to Parent & Me programs.


- Services for parents and caregivers were delivered by FRC staff and through partnerships with collaborating agencies, including La Leche League, Kings County Behavioral Health, Kingsview Behavioral Health, Cal Viva, Cal Fresh, SNAP ED, Bank of America, and UCCE Kings County.
- Preventive health and safety programs included eye exams and car seat installation assistance.
- FRCs recorded 17,992 total service contacts during the FY 2022-23 program year. This represents a 19% increase from the previous year, which may tied to the post-COVID recovery.




FRC Service Utilization Profile | 2022-2023








Developmental Screenings | 2022-2023

FRC Service Gaps | 2022-2023

- The FRC initiative also struggled with discontinuities in services. Funds were allocated for an Avenal FRC; however, the lack of a lead agency and challenges identifying operating space resulted in service gaps.
- The Kettleman City FRC also suspended its Parents as Teachers (PAT) home visiting services during the fiscal year due to transitions in staffing. The program was relaunched in FY 2023-2024.




Comprehensive Approaches to Raising Educational Standards (CARES) | 2022-2023


- The First 5 Kings County Commission invested \$85,834 into workforce development strategies through the Comprehensive Approaches to Raising Educational Standards (CARES) program.
- CARES audiences include ECE providers from licensed childcare centers and preschools, home visitation programs, Family Friend and Neighbor (FFN) providers, and Family Resource Center staff.
- CARES used funds to provide professional development to 172 individual participants.
 Services included reviews of personal growth plans, assistance with permit applications and higher education access, and provision of training, coaching and mentoring.
- CARES staff distributed newsletters and a training calendar to 3,416 recipients and provided stipends and materials to 51 participants.
- CARES members were invited to complete a survey at the end of the contract year. Surveys
 were administered electronically in English and Spanish by CARES program staff.





Conclusions & Next Steps

Building Capacity to Generate New Funding

Kings County funded partners continue to face reductions in Commission funding due to declining revenue. First 5 Kings County and its funded partners should look toward pursuing new avenues for fund development. This may require a proactive leadership role from the county and Commission to help build the professional capacity of partner agency staff to seek and obtain new funding (e.g., identifying funding opportunities, supporting proposal development, fiscal management).



Integrate EBPs and Emerging or Innovative Programming

Funded partners should continue to seek ways to integrate EPBs, model curricula, and innovative program models that are culturally responsive and that meet emerging needs in the community post-COVID. This may include parenting interventions and school readiness programs to prepare children for kindergarten. Using EPBs ensures that knowledge and research findings of professional experts guide programming, and that program strategies are proven effective for achieving positive outcomes for children and families.



Increase Partnership and Collaboration

First 5 Family Resource Centers have been highly successful collaborating with community partners. FRCs should continue to pursue opportunities to coordinate with other early childhood and family providers, including PreK and elementary school systems.



Identify and Reduce Duplication

First 5 leadership should pursue data driven strategies to identify and reduce any service overlap or unnecessary redundancies in programming.



Improved Data Infrastructure

First 5 California requires counties to track unduplicated participants across funded partners for accurate accounting of program reach. First 5 Kings County's data infrastructure has lagged, limiting the capacity for more robust evaluation of programs and services.

The loss of the Unite Us platform represents an added setback for the county. First 5 staff should work to identify low-cost data solutions to track referrals and client utilization across partners.

A. Background/History:

The First 5 Commission has scheduled annual program presentations by funded programs. This offers grantees the opportunity to share their successes, achievements, and progress from the last year.

B. Summary of Request, Description of Project and/or Primary Goals of Agenda Item:

The Special Needs project seeks to provide services to children identified as having or being at risk for developing a special need. This is a gap funding strategy to provide intervention to a population of children that because of stringent qualification standards, would otherwise not qualify for services under typical funding streams. Services provided through this project include conducting child development screenings and providing opportunities for children identified as having a special need for inclusion into the Parent & Me program. Additionally, this project provides parent mentorship support and education at Parent & Me Programs.

The Parent & Me program is a community-based program designed to strengthen the parent as their child's first teacher and provide hands-on growth experiences for both parent and child which can be repeated at home during the week. Parent and child attend a 1.5 to 2 hour session each week where they participate in activities that are developmentally appropriate for the child. The focus of the program is on children 0-3, however, children age 3-5 who do not have other options or parental preference are welcome. With emphasis on the process rather than results, parents are supported in discovering how and what their child is learning and how they can support their child's development.

C. Timeframe:

United Cerebral Palsy has been a component of the First 5 Kings County strategic plan since FY 2003/2004.

E. Staff Recommendation:

The Act established the California Children and Families Commission (First 5 California) and local county children and family commissions. The First 5 Association (F5 Association) was also created to represent the interests of all 58 county First 5s with state and federal policymakers and to share their collective insights, recommendations and knowledge to shape and influence policies that build better and more equitable early childhood systems and services. All 3 entities make up the First 5 Network and have worked collaboratively over the years to further the intent of the Act.

On January 11, 2024, during the First 5 Association's monthly Executive Director's meeting, a presentation regarding efforts to align the Network was made. Local county Commissions were urged to share the information with their staff and commissioners. Continued efforts to further align the Network will include discussion during the First 5 Association Annual Meeting, feedback on the efforts, as well as possible establishment of a Network Workgroup to continue the momentum of defining roles and expectations of all members of the Network.




